**B. Receive Planning Commission Recommendation on Hospital Campus Overlay District (HCOD) Ordinance and Set Public Hearing for September 16, 2013:**

**Moved** Metzger, supported Miller, to accept the Planning Commission recommendation on the Hospital Campus Overlay District ordinance for subsequent Council action. On a voice vote – **MOTION CARRIED.**

**Moved** Miller, supported Metzger, to schedule a public hearing for September 16, 2013 to hear public comment on the proposed Hospital Campus Overlay District ordinance. On a voice vote – **MOTION DEFEATED.**

**Moved** Miller, supported Metzger, to not refer the wording proposed by the Marshall Neighborhood Association and Oaklawn Hospital for §156.184 (F)(3) back to the Planning Commission and set for further Council action at the September 3, 2013 Council Meeting. On a voice vote – **MOTION CARRIED.**

**C. 2013 Marshall House Apartment Renovations – Bid Award:**

**Moved** Mankerian, supported Reed, to accept the low bid for \$179,200 from First Contracting, Inc. of Ovid, MI for the 2013 Apartment Renovation Project. On a roll call vote – ayes: Reed, Mayor Dyer, Mankerian, Metzger, and Miller; nays: none. **MOTION CARRIED.**

**D. Electric System Study with 5 Year Master Plan:**

**Moved** Miller, supported Mankerian, to approve an agreement with Spectrum Engineering for \$98,874.20 for the Electric System Study with 5 Year Master Plan. On a roll call vote – ayes: Mankerian, Metzger, Miller, Reed, and Mayor Dyer; nays: none. **MOTION CARRIED.**
