





When I see the lists of honors students in the Ad-Visor, it's ridiculous and disconcerting the percentage of names that are on them. I hate to be so critical of public schools, which I have long supported, as they are in everyone's cross hairs right now. I think teachers need support. I think it's hard to find excellent teachers, which is what we need. But I also think school systems need to be willing to be self-critical and to try to understand why increasing numbers of families are dissatisfied with them. 


16. How would you rate your level of satisfaction with City of Marshall utilities?




