2025 Incentive Application

Step 1: Make sure your project is eligible.

Step 2: Complete your project.

Install your new, energy-efficient equipment and remove your old equipment, following the specifications listed in this application.

Step 3: Apply for your rebate incentive.

Once your project is complete, it's time to request your incentive. All products must be purchased and installed in at the address of the utility account. Purchase must be within 6 months of submission. Please submit:

- A completed and signed application
- Itemized invoice /receipts. REBATES CANNOT EXCEED THE PRICE PAID AND DO NOT INCLUDE TAX.
- For central air conditioning units, please include the AHRI certificate(s).
- For ENERGY STAR ® products/equipment, include the ENERGY STAR ® logo and copy of invoice/receipt.
